NOTIFICATION

As per the direction of Hon'ble Supreme Court in SLP (civil) No. 7090/2021 dated 10-05-2022, and request of the Government, National Informatics Centre (NIC) has developed a software and submitted the reservation chart for the office of President and Vice-President in Urban Local bodies (CMC, TMC, TP) for the 10th term. The said reservation chart was filed before the Hon'ble Supreme Court of India on 12-09-2022 through an Affidavit by the State Government. Now, the Government decided to allot the same reservation as submitted to Hon'ble Supreme Court of India as per section 42 of the Karnataka Municipalities Act, 1964 and Rule 13 of Karnataka Municipalities (President and Vice-President) Election Rules, 1965.

Therefore, Government hereby allots the office of the President and Vice President to various categories for the TENTH TERM in respect of the following TOWN MUNICIPAL COUNCIL as per section 42 of the Karnataka Municipalities Act, 1964 and under rule 13-A and 13 of the Karnataka Municipalities (President and Vice President) Election (Amendment) Rules, 2024 issued vide order No. UDD 10 MLR 2024, dated: 05/08/2024.
